A. Call Meeting to Order.

The City Council of the City of Eagle Lake convened in regular session and allowed public attendance via zoom and telephonic means on the 25th day of May 2021, with the following members present:

B. Pledge of Allegiance.

C. Invocation.

Chief Federico Garza Jr. delivered the invocation.

D. Public Comments: Any person may comment on any subject, but Council must limit any discussion to placing the items on a future City Council agenda for discussion and/or action. (Comments made under this agenda item are limited to three (3) minutes per person. City Council members are excluded from public comments. This is in accordance with the Texas Open Meetings Act.)

Wilbert Williams on behalf of E.H. Henry Historical Corporation announced that a 3-day revival is planned for July 3-5, 2021 at the E.H. Henry School grounds.

E. Consent Agenda

Alderman M. Cooper made the motion to approve the minutes of the May 11, 2021 regular meeting and payment of accounts as presented. The motion was seconded by Alderwoman R. Cooper and it carried with all members voting AYE.

F. Items for Discussion and Action

3. Presentation of Community Pride Award Program. - Melissa Landin, City Manager

City Manager Landin announced that the City of Eagle Lake has launched a Community Pride Award Program to recognize residential and commercial property owners who have made significant maintenance improvements to their homes or businesses. The City will monthly choose a property or properties to display the Community Pride Award sign. A scoring system will be utilized in the selection of properties.

4. Presentation of City of Eagle Lake Re-designed Website. - Melissa Landin, City Manager

City Manager Landin reviewed and presented the re-designed new website that was designed by Municode. The City utilized CARES Grant funds for the much needed redesign which is now very comprehensive, up-to-date and can be easily navigated.

5. <u>Update on Eagle Lake Farmers and Community Market.</u> – Melissa Landin, City Manager

The City staff held a vendor/volunteer information meeting on the development of the Eagle Lake Farmers and Community market. A dozen vendors attended and provided input and guidance on the market's launch. The group decided to launch the market commencing on the first Saturday of September from 9:00 a.m. to 1:00 p.m. The City received approval from the vacant property owner adjacent to the Furniture Shoppe in the downtown area.

Alderman M. Cooper made the motion to approve Resolution No. R2021-08 Amending the Current Fiscal year 2020-2021 Budget for Unforeseen COVID-19 Expenses and Receipt of CARES Act Coronavirus Relief Funds. The motion was seconded by Alderman Contreras and it carried with all members voting AYE.

7. <u>Discussion and Action on 7-month Financial Statement for the Current Fiscal Year 2020-2021 Budget.</u> – Melissa Landin, City Manager

Bookkeeper Mike Martinez presented and reviewed the 7-month Financial Statement for the current Fiscal Year 2020-2021 Budget. Mr. Martinez presented a summary analysis of the revenue and expenses for the General, Utility and Airport Fund. Council held discussion.

Alderman M. Cooper made the motion to approve the 7-month Financial Statement as presented. The motion was seconded by Alderwoman Thomas and it carried with all members voting AYE.

8. Discussion and Action on Resolution No. R2021-09 Establishing a Committed Donation Fund for Revitalize Eagle Lake to Ensure that Donated Funds are Utilized for the Specific Purposes of the Organization as Stipulated by the Donor(s). – Melissa Landin, City Manager

City Manager Landin announced that Revitalize Eagle Lake has requested that City Council adopt a Resolution to establish a committed fund for donations to Revitalize Eagle Lake and the organization's managed projects. Council held discussion regarding the purpose of establishing a separate City account.

Alderwoman R. Cooper made the motion to approve Resolution No. R2021-09 Establishing a Committed Donation Fund for Revitalize Eagle Lake to Ensure that Donated Funds are Utilized for the Specific Purposes of the Organization as Stipulated by the Donor(s). The motion was seconded by Alderman Young and it carried with all members voting AYE.

9. <u>Discussion and Action on Rental of Community Center.</u> – Melissa Landin, City Manager

Alderman Contreras made the motion that the City commence opening the Community Center for rental until further notice and on a case-by-case basis. The motion was seconded by Alderman M. Cooper and it passed with all members voting AYE.

10. <u>Discussion and Action on Request for Variance to Allow for Shared 30-Foot Access Easement and Utility Easement on Proposed Subdivision at Barlass Estates.</u> – Victor Shimek, Public Works Director

City Manager Landin presented a variance request by Barlass Estates for subdivision of four properties. The Subdivision Ordinance requires that each property have direct access to a public street. The variance is requested to allow for a shared access easement and utility easement. City Attorney Charles Williams reviewed the Subdivision Ordinance and final approval is processed through the Planning & Zoning Commission.

Alderman M. Cooper made the motion to forward the Request for Variance to the Planning & Zoning Commission. The motion was seconded by Alderwoman R. Cooper and it carried with all members voting AYE.
