A. Call Meeting to Order.

The City Council of the City of Eagle Lake convened in regular session and allowed public attendance via in-person, zoom and telephonic means on the 22nd day of June 2021, with the following members present:

B. Pledge of Allegiance.

C. Invocation.

Chief Federico Garza Jr. delivered the invocation.

D. Public Comments: Any person may comment on any subject, but Council must limit any discussion to placing the items on a future City Council agenda for discussion and/or action. (Comments made under this agenda item are limited to three (3) minutes per person. City Council members are excluded from public comments. This is in accordance with the Texas Open Meetings Act.)

- 2. Payment of Accounts.

Alderman M. Cooper made the motion to approve the minutes of the June 8, 2021 regular meeting, June 10, 2021 workshop and June 15, 2021 special meeting and payment of accounts as presented. The motion was seconded by Alderwoman R. Cooper and it carried with all members voting AYE.

F. Items for Discussion and Action

3. Presentation and Discussion on City of Eagle Lake and Be A Champion Summer Grab-n-Go Meals Program for Youth. – Melissa Landin, City Manager

City Manager Landin announced that the City of Eagle Lake made contact with the Texas Hunger Initiative of Baylor University to assist in providing meals for the local youth. They were put in touch with Be A Champion (BAC) which is a statewide non-profit that provides meals for local youth. An application was submitted and the City was approved for two sites for distribution of the free meals. The two sites are currently being held every Monday at the Eagle Lake Community Center and every Wednesday at Iglesia Bautista Getsemani. The City also applied to be a sponsor for after school meals beginning in the fall using the same locations.

4. <u>Discussion and Action on Request for School Zone Designation(s)</u>, Associated Stop Signs and Any Other Signage in Proximity to the Eagle Lake Head Start and Eagle Lake Primary School. – Melissa Landin, City Manager

The City of Eagle Lake received a request from the RICE CISD to designate Partridge Lane near Eagle Lake Primary School a school zone due to increased and accelerated traffic. As per legal counsel, a public hearing is not required should a traffic engineer determine the school zones are

necessary (Texas Transportation Code). The traffic engineer will also determine where and if the stop signs are needed.

Alderman M. Cooper made the motion to provide the City Manager approval to contract with a traffic engineer to conduct the traffic study. Alderman Contreras seconded the motion and it carried with all members voting AYE.

Alderwoman R. Cooper commented on Alderman Young's statement regarding the train. This also occurred two years ago, and it caused someone's life.

Alderman M. Cooper expressed appreciation to the City workers in removing the lumber out of the streets.

Mayor Parr reminded everyone of the upcoming Juneteenth Celebration on Friday from 11:30 a.m. to 1:30 p.m., the City employee luncheon on Wednesday from 11:45 a.m. -1:15 p.m. and the July 4^{th} Fireworks. Mayor Parr thanked all the work that was done by the City staff during the storm.
