A. Call Meeting to Order.

B. Invocation.

Mayor Kelley delivered the invocation.

C. Pledge of Allegiance.

D. Public Comments: Any person may comment on any subject, but Council must limit any discussion to placing the items on a future City Council agenda for discussion and/or action. (Comments made under this agenda item are limited to three (3) minutes per person. City Council members are excluded from public comments. This is in accordance with the Texas Open Meetings Act.)

Benjamin Hayner announced that he is working towards achieving the Communication Merit Badge that required attendance in local government meetings where several points of view are given on a single issue.

E. Consent Agenda

All the following items on the Consent Agenda are considered to be routine and will be enacted with one motion. There will be no separate discussion of these items unless requested by the Mayor or a Council Member, in which event the item will be removed from the Consent Agenda and considered separately.

Councilmember Cooper made the motion to approve the previous minutes as presented. Councilmember Contreras seconded. VOTE: 4-0 in favor, motion passed.

F. Items for Discussion and Action

2. Discussion and Possible Action on Appointment of Mayor Pro Tempore. - Timothy Kelley, Mayor

Councilmember Cooper nominated Councilmember Contreras for appointment of Mayor Pro Tempore. Councilmember Contreras nominated Councilmember Maxwell for appointment of Mayor Pro Tempore. Councilmember Cooper withdrew her nomination. Councilmember Wood made the motion to accept the nomination of Councilmember Maxwell for appointment of Mayor Pro Tempore. Councilmember Parker seconded. VOTE: 4-0 in favor, motion passed.

3. Discussion and Possible Action upon Newly Designed City Logo. - Charles "Tink" Jackson, City Manager

City Manager Jackson presented a newly designed city logo that could be utilized in promoting Eagle Lake. The official city seal would still be used on all official correspondence. Council held a discussion about adding additional verbiage and simplifying the logo. No action was taken, and work will continue on the design.

7. <u>Discussion and Possible Action on Renewal of TML Health Employee Benefits Coverage.</u>

Councilmember Contreras made the motion to accept the renewal of TML Health Employee Benefits Coverage (TX Health Benefits Pool) for Plan Year October 1, 2023 to September 30, 2024. Councilmember Cooper seconded. VOTE: 4-0 in favor, motion passed.

8. <u>Public Hearing to Hear Comments Regarding the Juvenile Curfew Ordinance and Adoption of Ordinance No. 2023-03.</u> – Charles "Tink" Jackson, City Manager

Mayor Kelley opened the public hearing at 7:34 p.m. to hear public comments regarding the Juvenile Curfew Ordinance and Adoption of **Ordinance No. 2023-03**. City Manager Jackson stated that the City already has an ordinance in place, but it must be reviewed every three (3) years. No comments were heard. The public hearing was closed at 7:36 p.m. Councilmember Maxwell made the motion to approve Ordinance No. 2023-03. Councilmember Wood seconded. VOTE: 4-0, motion passed.

The ordinance is numbered 2023-03, and its caption reads "AN ORDINANCE MAKING IT UNLAWFUL FOR A MINOR, EXCEPT IN THE COURSE OF EMPLOYMENT, OR RETURNING FROM A SANCTIONED SCHOOL ACTIVITY, TO BE UPON THE STREETS OF EAGLE LAKE, TEXAS, BETWEEN THE HOURS OF 10:00 P.M. AND 5:30 A.M. THE NEXT MORNING; MAKING IT UNLAWFUL FOR ANY PARENT OR PERSON HAVING LAWFUL CUSTODY TO PERMIT A MINOR TO BE UPON THE STREETS WITHIN SUCH TIME LIMITS, UNLESS THERE 'IS A NECESSITY THEREFORE; PROVIDING THAT ANY VIOLATION OF THIS ORDINANCE SHALL BE A CLASS C MISDEMEANOR AND UPON CONVICTION SUCH VIOLATOR SHALL BE FINED A SUM NOT LESS THAN \$25 OR MORE THAN \$500; REPEALING CURFEW ORDINANCE 2019-03; PROVIDING FOR A SAVINGS".

9. <u>Discussion and Possible Action on Resolution No. R2023-08 Amending the 2022-2023 Fiscal Year Budget for Allocated Transfer Funds for Administrative Support from the Airport Fund to the General Fund.</u> – Charles "Tink" Jackson, City Manager

F. Items for Discussion and Action

11. Administration

- City Manager Report: Welcomed new city councilmembers. Hired new utility billing clerk Gabrielle Morales. Met with local representatives of the Wintermann Foundation to discuss the airport property and new businesses in the city. Rise Broadband is near completion and connections will take place soon. New swings have been ordered for the city park with Rise Broadband donating \$1,000. The swimming pool is open for the summer and last years' repairs did not last. LCRA presented a check for \$50,000 for the Eagle Lake Volunteer Fire Department to utilize for a new roof. The proposed road bond continues, and discussions have taken place with citizens to address any concerns. The county wide mayor/manager luncheon was held in the city. A review has been taking place regarding the city investment policy and a report will be presented at the next meeting. Budget season will begin soon, and meetings will be scheduled for the end of July.

11. Public Works

- Public Works Director Report: The fire hydrant was installed behind the bank property on East Main. Rise Broadband is complete with boring and a total of seven (7) gas lines were hit during the process. Accurate Water Meter is pending 80 meters for completion of the project; and all the water wells will be on a meter. A training session will be scheduled to present the Beacon portal to the residents. The swimming pool opened on Saturday. Mosquito spraying is scheduled accordingly and continues. Repair work is taking place on the pumps and motors at the water plant.

- Monthly Reports: Code official Antonio Rodriguez reviewed the monthly permit summary report.

14. Airport

- Working with TxDOT Aviation regarding RAMP funding and the Master Plan.

Olive Baptist Church is having a kickball tournament on Saturday at E.H. Henry Park; extended Happy Father's Day to all the fathers; and inquired about painting the water tower and putting verbiage about the Rice Raiders.
