3. Engineering Update and Discussion regarding the 2023 Bond Street Improvement Project Timeline. – Charles "Tink" Jackson, City Manager

Engineer Jared Engelke with Strand Associates reported that the infrastructure surveying and project manual will be started soon. It is anticipated to go out to bid in May or early June with estimated project completion by the end of the year.

5. <u>Discussion and Action on Ordinance No. 2024-01 Ordering a General Election for May 4, 2024 to Elect a Mayor and Two (2) Councilmembers.</u> – Lina Ferguson, City Secretary

6. <u>Discussion and Possible Action on Resolution No. R2024-06 Amending the 2023-2024 Fiscal Year Budget for the Increase in General Fund Revenue for the Allocation from Colorado County to the Eagle Lake Volunteer Fire Department.</u> – Charles "Tink" Jackson, City Manager

Councilmember Cooper made the motion to approve Resolution No. R2024-06. Councilmember Wood seconded. VOTE: 5-0 in favor, motion passed.

7. <u>Ratification of the 2024 Eagle Lake Police Department Standard Operational Procedures.</u>

Councilmember Cooper made the motion to ratify the Eagle Lake Police Department Standard Operational Procedures as presented. Councilmember Wood seconded. VOTE: 5-0, motion passed.

8. <u>Discussion and Possible Action on Ordinance No. 2024-02 Adding Article 2.05 Registration of Dogs and Cats, Amending Section 2.02.001 Rabies Vaccination, and Amending Section 2.02.007, Guard Dogs and Attack Dogs, of Article 2.02, Dogs and Cats, of Chapter 2, Animal Control to Update Vaccination Requirements and Add Registration Requirements. – Charles "Tink" Jackson, City Manager</u>

Councilmember Cooper made the motion to approve **Ordinance No. 2024-02**. Councilmember Wood seconded. VOTE: 5-0, motion passed.

9. <u>Discussion and Possible Action on Ordinance No. 2024-03 Ordering the Replacement of Certain Water Service Lines Identified as Non-Compliant under Title 30 Texas Administrative Code, Chapter 290.</u> – Charles "Tink" Jackson, City Manager

To bring the water service lines in compliance, homeowners will not be charged for permits and inspections will need to be completed. Doorknockers will be delivered to homeowners on the list. Councilmember Cooper made the motion to approve **Ordinance No. 2024-03**. Councilmember Wood seconded. VOTE: 5-0, motion passed.

10. <u>Discussion and Possible Action to Amend the Eagle Lake Community Center Rental Agreement and Rules and Regulations.</u> – Charles "Tink" Jackson, City Manager

Councilmember Maxwell made the motion to approve amending the rental agreement and rules and regulations. Councilmember Wood seconded. VOTE: 5-0, motion passed.

11. <u>Discussion and Possible Action on Ordinance No. 2024-04 Amending Ordinance No. 2023-06 City of Eagle Lake Master Fee Schedule and Amending All Ordinances in Conflict.</u> - Charles "Tink" Jackson, City Manager

Councilmember Cooper made the motion to approve **Ordinance No. 2024-04**. Councilmember Parker seconded. VOTE: 5-0, motion passed.

  - Police Department: Chief Chaney gave his monthly department report; new officer Mario Alcala started; Sgts. Dustin Blackburn and Gonzales graduated from sergeant academy; Officer Eliut Lopez was promoted to lieutenant; two narcotic raids with the Task Force took place; and the fire at the Icehouse is pending the fire marshal investigation.

Councilmember Parked inquired if Mr. Lowe's concern was addressed.

Councilmember Contreras stated that everything looks good, and the city is moving forward.
